CLUSTER DEFINITION

- "Clusters are geographic concentrations of interconnected companies and institutions, in a given field. Clusters comprise a group of related industries and other entities important in terms of competition. These include, for example, suppliers of specialized inputs such as components, machinery and services, or providers of specialized infrastructure. Often, clusters extending to different downstream channels and customers and laterally to manufacturers of complementary products and the industries related by skills, technologies or common inputs. Finally, some clusters include governmental and other institutions such as universities, standards agencies, think tanks, vocational training providers and employers to provide specialized training, education, information, research and technical support "Michael Porter
- At EU level, innovative clusters are considered the "engine" of economic development and innovation, they represent a framework for business development, collaboration between companies, universities, research institutions, suppliers, customers and competitors located in the same geographical area (local , regional, national, trans-national). - The current cluster policy paper elaborated in the frame of a bi-lateral cooperation agreement between the German Government (represented by GTZ) and the Ministry of Economy, Trade and Business- Directorate for Industrial Policies was implemented by ZENIT company (2009)
- The Industrial Policy Document 2011-2013 has a chapter dedicated to cluster (economic agglomeration) and innovative cluster/competitiveness cluster (triple helix model)




Romanian Cluster Mapping

- The clusters recognised in the cluster mapping (elaborated by GTZ-Germany) represent a good basis for pre-identifying both national elite clusters and regional clusters. The study recommends to apply a simple set of indicators. Such as:
 - share of employment in the cluster relative to total industrial employment in Romania /region
 - Number of firms in the sector relative to total number of firms in RO/region
 - Export value of the sector as compared to total national/regional export value
- The "bottom up" approach –at regional level (a number of innovative clusters appeared in several economic areas such as ICT, furniture, textile-clothing, automotive, electronics, agro-food, tourism, renewable energies, maritime and aviation)

The role of public authorities

METB-Directorate of Industrial Policies

- Cluster development is a market driven phenomenon following a bottom up approach where an entrepreneurial mindset is a key ingredient
- Public authorities can play a role in supporting cluster development (cutting down administrative hurdles, promoting national platforms for information-sharing, support schemes – public funds and structural funds etc)
- The role must not be confused with "governance" of clusters (see collaboration agreements and partnerships as well as identifying business opportunities)
- Coordination of the activity of clusters within regional Projects (Adriatic Danubian Clustering; 3^{rd and 4th} calls South East Europe Program; Danube Strategy; Competitiveness and Innovation Program-CIP; Framework Program 7 etc)
- Facilitate the exchange of best practices with EU Member States (Hungary, France, Germany, Sweden, Italy; Slovenia etc) and candidate countries (Croatia, Macedonia etc); Norway, Japan



Directorate for Industrial Policies (continuation)

Databases for benchmarking clusters using

- The European Cluster Observatory Mapping Database that is a diagnostic tool to identify clusters (employment data; export data; an innovation index etc)
- The Monitor Global Cluster Mapping Database

Collaboration with ROCA(Romanian Cluster Association)

Cluster Management –training courses in partnerships with Spain, Austria, Denmark; CIP call etc

Support for SME participation in clusters by further implementing the recommendations made in the SBA revised

Financing of the clusters (exchange of best practices with Hungary, Poland; Norway etc); Archidata Italy consortium;

Participation of clusters at international events/fairs for networks and internationalisation
